

# Extra Help or Low-Income Subsidy Support for Medicare Part D



Medicare Part D coverage helps cover the cost of prescription drugs, including recommended vaccines. People can either enroll in a Part D plan in addition to Original Medicare (Parts A and B), or join a Medicare Advantage (MA) plan that offers Part D coverage.<sup>1</sup>

### Medicare Part D benefits for 2025<sup>1-4</sup>

Although Part D plans may vary in cost and specific drugs covered, Medicare requires that all meet a set level of coverage, also known as the standard benefit.

Most Part D plans charge a monthly fee, called a premium, that can vary depending on the specific plan selected. Typically, a higher premium may offer greater coverage and lower out-of-pocket costs.

### Medicare Part D drug tiers<sup>5-7</sup>

Medicare Part D plans organize drugs into different "tiers," or levels of coverage, with different costs for each tier. Generally, a drug in a lower tier costs less than a drug in a higher tier. Each plan has its own tier breakdown.

### Example costs per drug tier under a Medicare Part D plan

Tier	Drug Type	Cost for patients
1	Preferred generic	Approximately \$0 to \$7 per drug
2	Generic	Approximately \$0 to \$12 per drug
3	Preferred brand	Approximately \$40 to \$47 per drug
4	Non-preferred drug	About 39% to 50% of the drug cost
5	Specialty	About 25% to 33% of the retail drug cost

Extra Help, also known as Low-Income Subsidy (LIS), supports patients with limited resources and income with the cost of Part D, including premiums, deductibles, coinsurance, and copays.

## Getting Started With Extra Help

### Who qualifies for Extra Help?<sup>6</sup>

Certain people automatically get Extra Help, including those who are enrolled in Medicaid, Medicare Savings Programs, or Supplemental Security Income (SSI) benefits. People who may be eligible for Extra Help but aren't automatically enrolled can contact the Social Security Administration (SSA) or their state Medicaid agency or apply online.

After patients are approved, receiving support through Extra Help is fairly quick and easy. Participants will receive an alert that they are approved, as well as information on their reduced costs.

### **Medicare Prescription Payment Plan**

If you do not qualify for Extra Help and would like help managing your out-of-pocket drug costs, you may benefit from enrolling in the Medicare Prescription Payment Plan (MPPP).

The MPPP may help by spreading out your drug costs, including your deductible, over the year, but works best if you sign up earlier in the year, especially if you anticipate high medication costs.
